The Government of Mozambique (GoM) has requested an IDA (World Bank) funding to implement the Integrated Agriculture and Natural Resources Management Project (Landscape), and intends to apply part of the funds for the payment of expenses related to hiring Consulting Services to conduct a study in five river basins, namely: Meluli, Monapo, Mecuburi, Ligonha and Motomonho, in Nampula Province.

The objective of this consultancy is to elaborate Monographs, Scenarios and Strategic Plans for Integrated Development of Water Resources of the afore mentioned river Basins.

The consultancy firm must have a multidisciplinary team with at least 10 years of experience in similar projects, and professional qualifications of the following subject areas: Hydrology, Hydrogeology, Geology, Planning, Management and Integrated Development of Water Resources, Management of Water Demand, Socio-Economic and Environmental Sciences, Soil Science, Ecology Systems, Water Quality, Civil Engineering, Agriculture and Irrigation, Fisheries, Community Development, Cross-Cutting Issues, Law, Physical Planning, Geographic Information System (GIS) & Remote Sensing and Communication.

Now, the Ministry of Land, Environment and Rural Development, through, Integrated Agriculture and Natural Resources Management Project , invites interested and eligible consultants to submit Expression of Interest to provide the above services. Interested consultants must provide information indicating that they are qualified to perform the consultancy services (brochures, description of similar assignments undertaken, demonstrate appropriate skills for the consultancy, years of experience in the said field, including work experience, etc). Only Short-Listed consultants will be contacted.

The Consultancy firms will be selected in accordance to the World Bank procedures defined in the “Guidelines: Selection and Employment of Consultants by World Bank Borrowers” (edition of January 2011, revised in July 2014), and the contracting method will be QCBS.

The shortlisting criteria are: (i) the overall experience of the company; (ii) Experience in Africa (iii) similar works done.
